To the board at Franklin Phonetic School,

I need to rescind my contract due to unexpectedly moving. My husband, our two kids and I are selling our house because we are financially struggling and need to move from the area. This was a quick decision as we are falling behind in bills and the equity in our house will help us catch up. I didn't expect or think this would happen. I am so sorry as I really wanted to work there and be a part of the Franklin team. We are financially struggling and adding a \$3000 bill will really push us over the edge.

There are several reasons I feel like I should be allowed out of my contract, most importantly I am giving a 3 month notice before the school year begins for teachers. I believe the \$3000 is to protect Franklin from having to pay a substitute or if a teacher leaves in the middle of the school year. Franklin hasn't invested any money or time into me as an employee, therefore I do not owe money back to the school for any costs my employment caused. Per the Arizona Statute ARS 15-545 that is mentioned in the contract, it applies to certified teachers and I am not a certified teacher. Again, I am giving 3 months notice and it is not during the school year. I am moving and physically can not be at the school when I do not live in town.
