



CHILD IDENTIFICATION POLICY Franklin Phonetic Primary Charter School

The Franklin Phonetic Primary Charter School insures that all children, including suspected special needs children, are identified, located and evaluated. Local community agency resources, including community Child Finds, will be identified for referring parents of children from birth to two years who require or request screening, evaluation, or early childhood intervention services. The identification procedures for three to five year olds shall include screening and evaluation procedures consistent with considerations for older students. Franklin Phonetic Primary Charter School procedures for child identification include the following provisions:

- 1) For creating public awareness of special education and for informing parents of the right of children with disabilities:
 - a) information regarding screening and regarding the rights of children with disabilities is made available in the language that will be understandable to parents regardless of their ethnic, linguistic or cultural backgrounds.
 - b) annual efforts to create public awareness and to inform parent of their rights for children with disabilities will be integrated with the community activities in Yavapai County (inleuding Child Finds in each child's area of residence).
 - c) surrogate parents are requested when no parent can be found or the child is a ward of the state.
- 2. Identifying children with disabilities including considerate of academic, visual, hearing, communication, emotional and psychomotor challenges, including psychological testing, as is deemed necessary from the screening stage and Child Study Team directives of identification.
- 3. Testing and providing documentation in the language that is the student's Primary Language will be provided. The LEP (Limited English Proficient) students will not be discriminated against or weighted as more eligible for special education as a result of language differences from that of English Primary Speakers.
- If the indentification procedures indicate a possible exceptionality for the student in the educational setting, a referral shall be made and a certified school psychologist (selected by the Franklin Phonetic Primary Charter School Director of Special Education or the Principal) will be contracted to evaluate the child for possible placement. Any other current evaluation, paid for by the parent, will be accepted by the school from the outside psychologist, as long as the qualifications of the psychologists and the extend of testing meets or exceeds the criteria of Franklin Phonetic Primary School (see personnel in Special Education) for Ed-Psych testing.

5. COMMUNITY COLLABORATION FOR AN EFFECTIVE CHILD FIND

A. Establish Community-Based Public Awareness

The purpose for the public awareness requirement in Arizona Administrative Code, R7-2-401 C. is:

- 1) to inform parents and the general public of special education services available so they can appropriately refer children and their families to the right service provider.
- 2) to help parents and the general public recognize and "identify" signs that indicate a child may have a developmental delay or disability by providing information on typical development and academic standards for school progress to use as a comparison for how a child is functioning; and
- to clarify the criteria for eligibility for services and how early intervention and special education services can help a child benefit to reach his or her full potential.

Public awareness efforts can take a variety of forms, depending on the level of awareness the community already has. The first priority is to preschool special education, or school-aged special education services have a clear understanding of: 1) eligibility criteria for both Part C and Part B services; 2) how to refer children; and 3) required procedures for the eligibility determination process.

The Child Find Intergovernmental Agreement is intended to create a more "seamless system" for identifying and serving children birth to five. To accomplish this, public education agencies and early intervention service providers need to combine their collective public awareness efforts in their community. Maintaining close communication is the key to successful collaboration. By working together, families and residents will have a more clear understanding of the message that "there are children who have special needs and the earlier these children receive help, the better chance they have to reach their full potential".

B. Identify Potential "Referral Agents" to Become Partners for Child Find

1) Primary Sources Who Refer Families of Young Children to AzEIP:

Referral sources are the various places, organizations or persons that typically refer families to a service provider for assistance. They need to continually receive updated contact information and a supply of brochures, posters, etc. to remind staff to refer families to AzEIP. The following are primary referral sources that interface with families of young children and need public awareness on Child Find:

- a. hospitals, including prenatal and postnatal care facilities;
- b. physicians/clinics;
- c. parents/families;
- d. child care programs;
- e. public and private educational agencies;
- f. public health facilities;
- g. other social service agencies
- h. other health care providers;
- faith-based organizations;
- j. family support organizations; and
- k. behavioral health agencies.

{Note: Public schools need to become one of the primary referral sources to AzEIP.}

2) Primary Referral Sources that Refer Preschoolers to School Districts: Half of preschool children go to daycare or preschools and the other half remain home with their parents. Parents and preschool staff notice concerns with development and refer children for screening or evaluation. Public awareness information needs to be continually marketed to parents, preschools and all of those agencies and organizations that interface with young children. These are some, but not all to consider.

- a. Parents/relatives:
- b. Preschools/daycare centers/Head Start Programs;
- c. Physicians/Healthcare providers;
- d. Social Workers/DES/DDD support coordinators;
- e. School nurses, school secretaries, bus drivers;
- f. AzEIP Interim Service Coordinators (from participating state agencies).

{Note: AzEIP participating agencies need to become one of the top primary referral sources for preschool special education services.}

3) Primary Sources That "Find" and Refer School-aged Children:

Although school staff may have some general information about the existence of special education services, it doesn't mean they know how to appropriately refer a child or the eligibility criteria. All school-based staff are required to review the policies and procedures for child find on an annual basis. They need to receive an overview of the "red flags" for children who need to be screened, who to contact, and the required timelines for the eligibility determination process so they do not misinform others who may inquire:

- a. Teachers;
- b. Parents/families:
- c. School nurses, school secretaries, bus drivers;
- d. Counselors, administrators;
- e. Social workers:
- f. Transfer of records from previous school;
- g. Mental health professionals (support coordinators);

- h. Secure care professionals (probation officers, instructors); and
- i. Private school staff.

6. MARKETING STRATEGIES TO "FIND" CHILDREN IN YOUR COMMUNITY

B. Why do we need to expand Child Find efforts?

Child Find is an on-going search for eligible children needing early intervention or special education services. Letting people know what types of developmental indicators are cause for concern and how to refer families to have their child screened is essential to sufficiently "search to serve" children with delays and disabilities. Both AzEIP and public schools need to use every resource available to inform the public of the availability of early intervention, preschool special education, and school-aged special education services. Networking with multiple local resource agencies, especially those who also serve children, will provide more potential referral agents from the community.

B. Who should be included as partners for Child Find public awareness?

The Arizona Early Intervention Program, school districts, and charter schools are required to reach out to their communities through public automatic for they might employ a variety of ways to encourage community support for informing parents of young children.

Sensitivity to cultural and linguistic issues during the Child Find process is crucial. Issues such as culture, language, religion, educational achievement and mobility of families in the community all need to be given consideration and appropriate accommodations.

Monies from foundations, grants, or other public agencies might be tapped to help fund these efforts. Local sports teams from all levels, local businesses, community patrons and philanthropic individuals or organization could be considered when developing Child Find strategies. Volunteer organizations such as the Lions or Rotary clubs could be contacted and encouraged to support public awareness activities. Since the basis of good Child Find is communication, collaborative efforts that revolve around social activities in the community, such as fairs and potlucks, can be great opportunities for planning with volunteers and agencies.

C. Where can we reach potential partners in the community?

Providing information at places where parents are frequently found make information more accessible, and events. Some locations have proven successful in reaching parents in the community, such as those below:

- Restaurants
- Day Care centers
- Stores

- Gas stations
- Offices
- Recreational centers
- Churches
- Clinics
- Community centers

D. When can community partners best be recruited

Combining local community events with Child Find activities can provide an opportunity to provide educational information and awareness regarding upcoming screenings and child fairs. Such events may include but are not limited to the following:

- Holiday events (festivals, fairs, boutiques)
- Fund raisers (hospitals, schools, churches)
- Drawings (booths, displays, gifts)
- Cultural events (celebrations, seasonal events, craft fairs)
- Community picnics (athletic, employee events, recreational)
- Shows (cars, gems, crafts)
- Displays (galleries, collections, museums)
- Open house events (schools)
 Grand Openings at stores, resorts

E. How can we get the attention of the broader community?

Materials that are easy to read; but have plenty of useful information, are more helpful resources to parents. These handouts provide them with ready references and phone numbers. Some helpful "tools" have been:

F. What other ways can be used to market Child Find information?




TOP 10 reasons a kid would get run over.

Dear Parent(s) or Guardian(s) of Franklin Phonetic School Students:

The Franklin Phonetic School is sending home with each student a notice to parents and eligible students of their rights under the FERPA, IDEA and this policy. This notice will be provided in English and Spanish. The Franklin School will arrange to provide translation of this notice to other non-English speaking parents in their native language. If you need a Spanish copy of this note please let us know. The will include the following:

- The right of a student's parents and eligible students to inspect and review the student's education records.
- The intent of the Franklin Phonetic School to limit the disclosure of information contained in student's education records except (1) by the prior written consent of the student's parent or the eligible student; (2) as directory information; or (3) under certain limited circumstances, as permitted by the FERPA.
- The right of a student's parent or eligible student to seek or correct parts of student's education record he or she believes to be inaccurate, misleading, or in violation of student rights. This right includes the right to a hearing to present evidence that the record should be changed if the district decides not to alter it according to the parent or eligible student's request.
- The right of any person to file a complaint with the United States Department of Education, FERPA Office of the Franklin Phonetic School violates the FERPA.
- The procedure that a student's parent or an eligible student should follow to obtain copies of this policy and the locations where copies may be obtained.

STATEMENT OF RIGHTS

Parents and eligible students have the following rights under the Family Educational Right and Privacy Act and this policy.

- The right to inspect and review the student's education record.
- The right to exercise a limited control over other people's access to the student's education record.
- The right to seek to correct the student's education record, in a hearing if necessary.
- The right to report violations of the FERPA to the United States Department of Education, FERPA Office.
- The right to be informed annually about FERPA rights.

All rights and protections given parents under the FERPA and this policy transfer to the student when he or she reaches age 18 (except where the student is dependent) or enrolls in a postsecondary school. The student then becomes an eligible student.

Model Notification of Rights under FERPA For Elementary and Secondary Institutions

The Family Education Rights and Privacy Act (FERPA) affords parents and students over 18 years of age ("eligible students") certain rights with respect to the student's education records. They are:

(1) The right to inspect and review the student's education records within 45 days of the Day the District receives a request for access.

Parents or eligible students should submit to the school principal (or appropriate school official) a written request that identifies the record(s) they wish to inspect. The principal will make arrangements for access and notify the parent or eligible student of the time and place where the records may be inspected.

(2) The right to request the amendment of the student's education records that the parent or eligible student believes are inaccurate or misleading.

Parents or eligible students may ask Franklin Phonetic School to amend a record that

they believe is inaccurate or misleading. They should write the school principal, clearly identify the part of the record they want changed, and specify why it is inaccurate or misleading.

If the District decides not to amend the record as requested by the parent or eligible student, the District will notify the parent or eligible student of the decision and advise them of their right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent or eligible student when notified of the right to a hearing.

(3) The right to consent to disclosures of personally identifiable information contained in the student's education records, except to the extent that FERPA authorizes disclosure without consent.

One exception which permits disclosure without consent is disclosure to school officials with legitimate educational interests. A school official is a person employed by the District as an administrator, supervisor, instructor, or support staff member (including health or medical staff and law enforcement unit personnel); a person serving on the School Board; a person or company with whom the District has contracted to perform a special task (such as an attorney, auditor, medical consultant, or therapist); or student serving on an official committee, such as a disciplinary or grievance committee, or assisting another school official in performing his or her tasks.

A school official has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility.

(Optional) Upon request, the District discloses education records without consent to officials of another school district in which a student seeks or intends to enroll. (NOTE: FERPA requires a school district to make a reasonable attempt to notify the student of the records request unless it states in its annual notification that it intends to forward records on request.)

(4) The right to file a complaint with the U.S. Department of Education concerning alleged failures by the District to comply with the requirements of FERPA. The name and address of the Office that administers FERPA are:

Family Educational Rights and Privacy Act (FERPA) General Guidance for Parents

FERPA is a Federal law that applies to educational agencies and institutions that receive funding under a program administered by the U. S. Department of Education. Parochial and private schools at the elementary school levels do not generally receive such funding and, therefore, are not subject to FERPA. The statute is found at 20 U.S.C. § 1232g and the Department's regulations are found at 34 CFR Part 99.

Under FERPA, schools must generally afford parents: -access to their children's education records -an opportunity to seek to have the records amended -some control over the disclosure of information from the records.

Parents may access, seek to amend, or consent to disclosures of their children's education records, unless there is a court order or other legal document specifically stating otherwise. When a student turns 18 years of age or attends a postsecondary institution, the student, and not the parent, may access, seek to amend, and consent to disclosures of his or her education records.

Access to Education Records

Schools are required by FERPA to:

- provide a parent with an opportunity to inspect and review his or her child's education records within 45 days of the receipt of a request
- provide a parent with copies of education records or otherwise make the records available to the parent if the parent, for instance, lives
- outside of commuting distance of the school
- redact the names and other personally identifiable information about other students that may be included in the child's education records.

Schools are not required by FERPA to:

- Create or maintain education records;
- Provide parents with calendars, notices, or other information which does not generally contain information directly related to the student;
- Respond to questions about the student.

Amendment of Education Records

Under FERPA, a school must:

- Consider a request from a parent to amend inaccurate or misleading information in the child's education records;
- Offer the parent a hearing on the matter if it decides not to amend the records in accordance with the request;
- Offer the parent a right to place a statement to be kept and disclosed with the record if as a result of the hearing the school still decides not to amend the record.

A school is not required to consider requests for amendment under FERPA that:

- Seek to change a grade or disciplinary decision;
- Seek to change the opinions or reflections of a school official or other person reflected in an education record;
- Seek to change a determination with respect to a child's status under special education programs.

Disclosure of Education Records:

A school must:

- Have a parent's consent prior to the disclosure of education records;
- Ensure that the consent is signed and dated and states the purpose of the disclosure.

A school MAY disclose education records without consent when:

- The disclosure is to school officials who have been determined to have legitimate educational interests as set forth in the school district's annual notification of rights to parents;
- The student is seeking or intending to enroll in another school;
- The disclosure is to state or local educational authorities auditing or evaluating Federal or State supported education programs or enforcing Federal laws which relate to those programs;
- The disclosure is pursuant to a lawfully issued court order or subpoena; and
- The information disclosed has been appropriately designated as directory information by the school.

Annual Notification

A school must annually notify parents of students in attendance that they must allow parents to:

- Inspect and review their children's education records;
- Seek amendment of inaccurate or misleading information in their children's education records;
- Consent to most disclosures of personally identifiable information from education records.

The annual notice must also include:

- Information for a parent to file a complaint of an alleged violation with the FPCO;
- A description of who is considered to be a school official and what is considered to be a legitimate educational interest so that information may be shared with that person;
- Information about who to contact to seek access or amendment of education records.

Means of notification:

- Can include local or student newspaper; calendar; student programs guide; rules handbook, or other means reasonable likely to inform parents;
- Notification does not have to be made individually to parents.

Complaints of Alleged Violations:

Complaints of alleged violations may be addressed to: Family Policy Compliance Office US Department of Education 400 Maryland Avenue, SW Washington, DC 20202-5901

Complaints must:

- Be timely submitted, not later than 180 days from the date you learned of the circumstances of the alleged violation
- Contain specific allegations of fact giving reasonable cause to believe that a violation has occurred, including:
 - Relevant dates, such as the date of a request or a disclosure and the date the parent learned of the alleged violation;
 - Names and titles of those school officials and other third parties involved;
 - A specific description of the education record around which the alleged violation occurred;
 - A description of any contact with school officials regarding the matter, including dates and estimated times of telephone calls and/or copies of any correspondence exchanged between the parent and the school regarding the matter;
 - The name and address of the school, school district, and superintendent of the district;
 - Any additional evidence that would be helpful in the consideration of the complaint.

Important Information Concerning School Volunteers and Fingerprint Clearance

At Franklin School, we encourage parents to participate in the learning process. Volunteering at the school is one way for parents to do this. We like to encourage parents to volunteer in their students' classes and/or in our lunchroom.

For the sake of safety and because of legal requirements, we have established a 2-Tiered Volunteer Program for those parents who are interested in volunteering at our school.

TIER 1 = These volunteers are involved in actively working with children (reading with students, conducting small reading groups, tutoring, etc). Tier 1 volunteers are permitted to work with small groups of children without having to be under the direct supervision of school staff. In order to qualify as a Tier 1 volunteer, a parent must hold a current fingerprint clearance card. To obtain a fingerprint clearance card, parents simply need to pick up paperwork from the Business Office and contact the local police department to have fingerprints taken. Once clearance has been granted, a clearance card will be sent in the mail. Tier 1 volunteers MUST have a fingerprint clearance card in order to work with children on campus.

TIER 2 = These volunteers come to help with odd jobs, but are under the direct supervision of a school staff member. Tier 2 volunteers are permitted to work with children, but may do so only while supervised. Because Tier 2 volunteers are always supervised, fingerprint clearance is not necessary.

If you are a parent interested in volunteering at Franklin School, please feel free to complete a volunteer application form and submit it to the office. You will be contacted by our Volunteer Coordinator regarding your preferences for days and times of volunteering. At this time, you will want to make it clear whether you will come as a Tier 1 or Tier 2 volunteer.

- > The programs ends April 21, 201 for the 2011-2012 "COOL CA\$H" year.






Junior High and Beginning band parents **DO NOT** arrive to pick up your child until 3:45 or you will be asked to **GO BACK** to the end of the line.






